

In 2013, the sold out crowd of 500 enjoyed a live and silent auction, dinner, entertainment and surprise guests. CHANEY'S DAIRY DASH JUNE 12, 2014

The first annual Chaney's Dairy Dash 5k Run/ Walk benefitting United Way of Southern Kentucky was held in June of 2014 at Chaney's Dairy Barn. More than 100 participants and numerous sponsors showed their support by generating more than \$3,200 for the organization. As well, dozens of shoes were collected and donated to local children who otherwise would not have a new pair of shoes.

WGGC 95.1 RADIOTHON JUNE 19, 2014 6AM-6PM

The first annual WGGC 95.1 Radiothon to support United Way's Dolly Parton's Imagination Library took place on June 19th from 6AM – 6PM in partnership with WBKO. As a result of generous sponsors and call in donations, the event was able to provide the enrollment for 254 kids into the Imagination Library Program which puts books in the hands of kids.









REINHART FOODSERVICE HANDBAGS FOR HOPE MAY 15, 2014

On May 15th, the first annual Reinhart Foodservice Handbags for Hope Purse Auction took place at the Bowling Green Country Club. With more than 40 supporters in attendance, \$9,480 was raised as a result of the event. The dollars raised will help send one book per month in the mail to children under the age of 5 who are enrolled in the Imagination Library program free of charge.

TOGETHER WE CAN MAKE CHANGE HAPPEN



United Way of Southern Kentucky committed to Community Impact transformation in December 2012. This transformation is a new way of doing business for UWSK with a focus on long term change in our community. The foundation of this plan began with turning outward to the community through a three pronged approach: 1) Developing and disseminating a Community Issues Survey asking community members to rank the top ten issues in our community 2) Conducting a series of Community Conversations in which community members are asked what kind of a community they want to live in and finally 3) Extensive research into Secondary Data. Looking forward, this approach will define the future of United Way's work in our community.

DAY OF CARING: JULY 31, 2013

The United Way Day of Caring is a one day, structured volunteer opportunity that provides participants with a peek at volunteering. On this one day, businesses make a commitment to offer their employees a chance to "step away from their desks" to provide hands-on, volunteer labor for a variety of projects. Team participation in the Day of Caring aids in building camaraderie and goodwill among employees while also helping the community. In 2013, more than 800 volunteers representing 64 companies completed more than 60 projects.

FEED THE NEED: FEBRUARY/ MARCH 2014

"Feed the Need" began in 2009 by United Way of Southern Kentucky in response to the need in our communities for increased food resources. After speaking with local food pantries that benefited from the drive in previous years, it was abundantly clear that there continued to be a need for this drive. Since its inception, "Feed the Need" has collected more than 304,000 items for local food pantries that have been distributed to individuals and families in need across Southern Kentucky.

In 2014, 110 companies and more than 800 volunteers collected more than 60,000 items that were distributed to food pantries in Allen, Barren, Logan, Simpson, and Warren counties.

WKU STUDENT UNITED WAY

Young people across the country are helping to improve their local communities by giving, advocating and volunteering. This powerful movement called Student United Way is helping to advance the common good. Student United Way is a campus based student led organization that works in partnership with the local United Way. Currently, there are more than 1500+ members in 80 clubs around the world spanning 5 countries and 23 states.

The Western Kentucky University Student United Way is a studentrun branch of United Way of Southern Kentucky that became an official organization on the WKU campus during the fall of 2012. They are a group of student volunteers devoted to lending their time and talent for the benefit of our surrounding community. Through their efforts, they hope to encourage other students to become both active members of the WKU Student United Way and volunteers within the community. Ultimately, their goal is to inspire members to continue giving and volunteering beyond their careers at WKU.

DOLLY PARTON IMAGINATION LIBRARY

Investments in high quality preschool education affect not only the lifelong success of the individual participants, but over time lead to positive effects on social issues such as poverty, personal abuse and substance abuse.

To assist in getting books into the hands of all children, United Way of Southern Kentucky adopted the Dolly Parton Imagination Library in 2011 to help spark a child's interest in reading and learning. Any child, from birth to the age of five, can enroll in the program. Once enrolled, the child will receive one age appropriate book every month in the mail until they reach the age of five. The program is offered in Allen, Barren, Butler, Edmonson, Hart, Logan, Metcalfe, Monroe, and Warren counties through United Way of Southern Kentucky.








FINANCIAL ACCOUNTABILITY

When you give to the United Way of Southern Kentucky, you entrust your hard-earned dollars to an organization that takes this trust very seriously. Volunteers make sure that designated funds are distributed according to the donor's wishes and then oversee the allocation of undesignated funds to all programs through community investment volunteer teams. These panels conduct annual reviews and closely monitor agency services. Just as important, United Way of Southern Kentucky is audited by an independent auditing firm and is carefully scrutinized by volunteers. United Way of Southern Kentucky also annually files the IRS Form 990 required for non-profit organizations. 
